

Fathom Reads Digital Content Terms of Service

The services and/or products provided to you by Fathom Technologies, LLC, d/b/a Fathom Reads (hereinafter referred to as "FATHOM") its subsidiaries, agents and affiliates, in conjunction with our Digital Content Offerings (hereinafter referred to as "Digital Content") are subject to the following Terms of Service. FATHOM reserves the right to update these Terms of Service at any time, with or without prior notice to you. You understand and agree that if you access and make use of our Digital Content the Terms of Service then existing will govern your access and use. Similarly, any future release, update, or other addition to our Digital Content shall be subject to the Terms of Service then existing.

Access to Digital Content

This Digital Content is offered to families, schools, public libraries, and other licensees (each of whom individually is a "Licensee" and collectively are "Licensees") and their qualified children/students, parents/faculty and staff (hereinafter each individually referred as "User," "you" or "your") as part of the overall licensed content made available to our Licensees. The Digital Content is made available to you exclusively through a dedicated web portal ("Web Portal") and/or Mobile Applications established for the Licensee of which you are a member and is accessed by you either with (1) credentialed login by authorized user specific email or username and password or (2) incognito login using secure login link with site specific password established by the Licensee for your use.

Credentialed login is generally recommended as it enables access to the fully integrated Learning Management System (LMS) which includes:

- School, teacher, and student dashboards
- Tracks reading and quiz performance
- 1000s of multi-language questions and quizzes in a shared database
- Create, assign, grade quizzes
- Messaging system

For schools choosing incognito, their users may opt for credentialed login at any time making it possible for individual teachers and their assigned students to use the LMS.

FATHOM hereby grants you permission to access, download, and use our Digital Content as set forth in these Terms of Service. In order to access our Digital Content, FATHOM requires you to be an active child/student, parent/faculty or staff member of a Licensee. FATHOM requires each Licensee to maintain identification information about each of its members who are authorized Users with access to the Digital Content. FATHOM further reserves the right to request such identification information at any time to verify access authority by any Users.

You are responsible for maintaining the confidentiality of your passwords, usernames and e-mail addresses required for access to the Digital Content. You may not authorize anyone else to use your password, username or email address to access Digital Content. You are entirely responsible for any and all activities that occur using your access credentials.
